## **First Commerce Credit Union & Secure Records Solutions to provide a FREE Community Shred Day on February 24**

NASHVILLE, GA – First Commerce Credit Union announced they will partner with Secure Records Solutions to offer members, residents and small businesses in Nashville, GA, the opportunity to have sensitive paper records shredded and recycled during a free “drive-thru” Community Shred Day on Wednesday, February 24, 2021, from 11 a.m. to 1 p.m.

“At First Commerce, the security of our members’ information is a top priority. Partnering with Secure Records Solutions to offer their professional services to the community is a natural fit for us,” said Dale Harper, Nashville Financial Center Manager. “Together, we can bring security, recycling, and convenience to our community.”

Paper materials will be collected at First Commerce’s Nashville financial center at 301 South Davis Street. Paper-based documents will be accepted for free with a limit of 3 boxes or bags per person. There is no need to remove staples, paper clips or file folders. In addition, secure destruction of hard drives and recycling of electronics will be provided for a fee. Fees will vary based on the item. Credit cards will be accepted on site.

During the event, Secure Records Solutions and First Commerce will be taking extra safety precautions due to COVID-19. In observance of CDC social distancing and health guidelines, the Shred Day will be drive-thru only. Team members working at the event will wear masks and gloves. Participants should remain in their vehicles and place bags or boxes of items to be shredded in vehicle trunks or rear space to allow easy access for team members to get the materials.
